

## OFFICIAL RULES

# Be Entered to Win \$1,000 Holiday Shopping Spree By Signing Up for eStatements By November 30, 2009

### How to Enter:

All members who have signed up for Eglin Federal Credit Union's (EFCU's) eStatements by November 30, 2009, and have an "active" or open account on November 30, 2009 will be automatically entered in the drawing. To enroll in eStatements, you must have a *Home Branch* PIN. If you need to apply for *Home Branch*, visit any EFCU branch during normal business hours Monday through Friday. The application for *Home Branch* is also available on our web site [www.eglinfcu.org](http://www.eglinfcu.org). You may print, complete and mail the form to us at 838 Eglin Parkway NE, Ft. Walton Beach, FL 32547. Applications by mail require a notarized signature.

To enter without enrolling in eStatements, hand print the words "**Sweepstakes**", your name, address, city, state, zip code, daytime and evening phone numbers and date of birth on a 3" by 5" card and mail it in an envelope to: **Sweepstakes**, P O Box 854, Shalimar, FL 32579. Entries must be received by EFCU no later than close of business (5:00 PM CST) on Monday, November 30, 2009 and become the property of Eglin Federal Credit Union and will not be returned.

Regardless of the method of entry, you are limited to one (1) entry. By participating in the **Sweepstakes**, you agree to the terms and conditions of these Official Rules, and to accept the decision of the random drawing witness as final in all matters relating to the **Sweepstakes**.

### Eligibility:

The **Sweepstakes** is open to all members of Eglin Federal Credit Union and individuals who are 18 years of age or older at time of entry. To enter the **Sweepstakes** you are not required to purchase goods or services from EFCU. EFCU employees, officials, family members and individuals that reside in the same household or share an account relationship with employees or officials are ineligible to win.

### Prizes:

Five winners will be randomly selected at the end of the 2-month promotion. Each winner will receive \$1,000 for holiday shopping. Prizes are non-transferable.

### Drawings:

The drawing will be held on Tuesday, December 1, 2009 and will be witnessed by an unaffiliated party designated by EFCU. The odds of winning are dependent on the number of eligible entries received. You need not be present at the drawing to win.

The winners will be responsible for the payment of any and all applicable federal, state and local taxes imposed on the prize, and may be required as a condition of receiving a prize to provide EFCU with his or her Social Security number so that appropriate reports may be filed with the appropriate taxing authorities.

The winners may be required to sign and return an affidavit of eligibility within 14 days of notification attempt. If such an affidavit is required, a failure to return the affidavit in the time noted will result in disqualification of the winner's entry and the random selection of an alternate winner.

### Notification:

The winners will be notified by phone, mail or e-mail at the number or address listed in EFCU's records or on mail-in entry cards within three (3) business days following the drawing. EFCU is not responsible for notifications that are misdirected or not received because of incorrect or inoperable numbers or addresses. If EFCU, after reasonable effort, is unable to contact a winner within ten (10) business days from the first notification attempt, that winner may be disqualified and an alternate winner may be selected. Any notification or prize returned as "undeliverable" will result in the disqualification of the winner and the awarding of that prize to an alternate winner.

### Consent to Publicity and Release:

Winners agree that at EFCU's discretion, we may publish the names of winners in our quarterly newsletter and on our web site, [www.eglinfcu.org](http://www.eglinfcu.org), and may also request that a photograph of our winners be taken at the time the prize is presented which may be published in the newsletter and on our web site.
